**RADIO NAVIGATIONAL WARNINGS** for east Adriatic coast are broadcasted daily by Croatian coastal radio stations.

**DUBINE I VISINE** određene su u metrima. Dubine se odnose na srednju razinu nižih niskih voda živih morskih mijena, a visine na srednju morskiju razinu.

**DEPTHES** are in meters and are reduced to Chart Datum which is Mean Lower Low Water Springs.

**HEIGHTS** are above Mean Sea Level.

**SEKTORI VIDLJIVOSTI** svjetala i pokriveni smjerovi imaju vrijednost more-kopno (otok), ako nije drugačije naglašeno. Daljina vidljivosti svjetala izrađena je u nautičkim miljama za visinu motriteljeva oka (5m).

**SECTORS OF LIGHTS.** The limits of sectors and areas of visibility, and the alignment of direction lights and leading lights are given as seen from seaward. Range in nautical miles is given for the height of eye of the observer - 5 metres.
